

OUR HISTORY

The first strategic meeting with key role players was held on 2 August 2007 and attended by 60 forensic practitioners. The main objective of the meeting was to decide whether there is a need for a local body to represent the commercial forensic industry because it was felt that:

- The forensic industry has been largely undefined and fragmented;
- The forensic industry comprises of a wide range of professionals;
- A need was identified to cohere and regulate the industry in South Africa.

The first Strategic Committee members elected were:

Flip Stander (Deloitte), Adv Jan Henning (SC), Ernst Pienaar (Sanlam), Indhren Perumal (AG), Heila Dreyer (SIU), Anne-Marie Krugell (SME), Susan Potgieter (SABRIC), Robert Cameron-Ellis (ACFE), and Prof. Jan van Romburgh (NWU)

During that period:

- A mandate was given to define, cohere and regulate the industry and map the way forward;
- 15 Meetings were held until the ICFP inaugural meeting in May 2010;
- Proposal delivered in March 2010.





2011

The ICFP was established in 2010 to cohere, coordinate and regulate the forensic industry in South Africa. Key steps included forming a representative board, incorporating the company, determining membership criteria, and establishing "grandfather clauses" to manage the initial membership process.

The ICFP's first year was challenging, with no staff, funding, or an office. Despite this, the ICFP evaluated and awarded 900 memberships, held the first conference and completed founding documents. The ICFP appointed its first executive and administrative staff.

2013

2014

In its first operational year, the ICFP appointed Chris de Beer as Executive Manager and launched a qualifying exam with three modules. 39 students enrolled for 69 modules, receiving 69 subsidies. Prep courses began in May 2013. The annual conference was held at Birchwood. The Board focused on strategic direction and value proposition, moving away from industry-specific representation.

The ICFP's qualifying exam expanded to 5 modules, with around 120 students enrolled in 175 modules, receiving 100 subsidies. The annual conference was held at Emperors Palace. A new criteria was introduced for experienced members. The ICFP refined its strategic objectives and value proposition during a strategic session.



The ICFP applied for recognition as a nonstatutory professional body with the South African Qualifications Authority (SAQA), and the awarding of the professional designation (FP)SA. R395,000 has been paid in member subsidies for studying the board examination.

2016

The Continuing Professional Development (CPD) policy was implemented in January 2016.

2017

The ICFP was recognized as a non-statutory professional body by the South African Qualifications Authority (SAQA), and the professional designation (FP)SA was awarded.

2018

Regional Committees were established.



2020

The ICFP Board embarked on a process to develop professional standards for the industry. The University of South Africa (UNISA) Postgraduate Diploma in Forensic Auditing was fully accredited by the ICFP.

Four work streams have been established to research and develop the following standards:

- Attribute Standards
- Reporting Standards
- Client and Engagement Acceptance Standards
- Information Gathering Standards

2021

2022

The University of Pretoria, Department of Auditing MPhil (Fraud Risk Management) and Postgraduate Diploma in Investigation and Forensic Accounting was fully accredited by the ICFP.

At the AGM on 14 July 2022 members approved amendments to minimum requirements for awarding the professional designation (FP)SA The following professional standards were approved:






The Client and Engagement Acceptance Standards were approved at the AGM. The ICFP developed a competency framework to define and measure the skills, knowledge, abilities, and behaviours required for career growth in the forensic industry. 
MEMBERSHIP ETHNICITY









BOARD EXAMINATION



The ICFP Board examination are designed to equip learners with the fundamental knowledge and skills necessary to effectively participate in the prevention and combating of commercial crime and related irregularities.

THE ICFP BOARD EXAMINATION CONSIST OF THE FOLLOWING 5 MODULES: COMMERCIAL FORENSIC ACCOUNTING (CFA) COMMERCIAL FORENSIC LAW (CFL) COMMERCIAL FORENSIC INVESTIGATION (CFI) COMMERCIAL FORENSIC INFORMATION TECHNOLOGY (CFIT) PRACTICE AND FRAUD RISK MANAGEMENT (PFRM)

Commercial Forensic Accounting

The module aims to equip learners with a detailed knowledge base of key terms, principles and theories in the field of commercial forensic accounting, which they can apply in written arguments, debates, and oral presentations. Learners will gain insight into transactional cycles, including their purpose, sequence, core documentation, associated business risks, concepts of internal control and risk, and the limitations of internal control. The course also covers basic accounting principles, such as debits and credits, income, expense, debtors and creditors, books of first entry, and trial balances. Learners will apply their knowledge of the practical application of flow-of-funds analysis principles, including interpreting bank statements and other documentation to determine the source and flow of funds with reliable evidence. Additionally, the module teaches learners to identify and apply basic research methods and technologies appropriate to commercial forensic accounting, such as identifying, gathering, organising, critically analysing, evaluating, and interpreting relevant information, and writing up findings in assignments.

Commercial Forensic Law

This module equips learners with a detailed knowledge base of key terms, principles, and theories in commercial forensic law. Learners will gain insight into the effect of the Bill of Rights on forensic investigations and apply their knowledge to identify specific offences, such as fraud and money laundering. The course covers relevant aspects of South African law of evidence, labour law concepts, and asset recovery procedures. Learners will also learn about reporting duties of roleplayers in forensic investigations and apply basic research methods to the field of commercial forensic law. Through written assignments, case studies, and oral presentations, learners will demonstrate their ability to critically analyse and interpret information in this specialised domain.

Commercial Forensic Investigation

This module equips learners with a detailed knowledge base of key terms, principles, and theories in commercial forensic law. Learners will gain insight into the effect of the Bill of Rights on forensic investigations and apply their knowledge to identify specific offences, such as fraud and money laundering. The course covers relevant aspects of South African law of evidence, labour law concepts, and asset recovery procedures. Learners will also learn about reporting duties of role-players in investigations and forensic apply basic research methods to the field of commercial forensic law. Through written assignments, case studies, and oral presentations, learners will demonstrate their ability to critically analyse and interpret information in this specialised domain.

Commercial Forensic Information Technology

This module equips learners with a detailed knowledge base of key terms, principles, and theories in commercial forensic information technology. Learners will apply their understanding to arguments and debates, covering fundamentals such as computer forensics, digital evidence, and forensic data analytics. The course provides insight into general IT concepts relevant to forensic practitioners and the application of South African law pertaining to data privacy and the admissibility of digital evidence. Learners will demonstrate their ability to conduct digital evidence investigations and explore other areas of forensic technology, including cybercrime and mobile device forensics. Appropriate research methods will be identified and applied to critically analyse and interpret relevant information in assignments.


Practice and Fraud Risk Management

This module equips learners with detailed knowledge of ethics, attribute standards, and key terms applicable to commercial forensic investigations and fraud risk management. Learners will demonstrate moral sensitivity and ethical reasoning when dealing with concerns in practice. The module provides insight into the roles of various stakeholders and the positioning of commercial forensic practice within the context of commercial crime. Learners will apply detailed knowledge of engagement risks relating to practice management and explain how fraud risk management forms part of governance and risk management to prevent, detect, and respond to commercial crime. The module covers commercial forensic reporting standards and basic research methods to critically analyze and interpret relevant information in assignments.




BOARD EXAMINATION ASSESSMENT

The preparatory courses to the Board examination utilise a combination of formative assessment, including a minimum of two written assignments and/or case studies, and a summative assessment in the form of a 3-hour, 100-mark sit down examination.






2023 Pass rate

FROM CHAIRPERSON ETHICS AND DISCIPLINARY COMMITTEE

The Ethics and Disciplinary Committee of the ICFP is currently handling three (3) disciplinary cases, two (2) of which are intricate, necessitating the engagement of independent legal professionals for assistance.

Tenders/ Request for Proposals (RFPs)

The ICFP intervened in seven (7) Request for Proposals (RFPs), Tenders, or Bids issued in 2023, and three (3) in 2024. These procurement opportunities either omitted the inclusion of ICFP members as a prerequisite or presented unrealistic requirements.

Following the intervention of the ICFP, the issuing organisations responded positively by promptly revising the requirements.

CONFORMANCE EVALUATION PROGRAMME

The Institute for Commercial Forensic Practitioners (ICFP) continues to advocate for the selfregulation of the Commercial Forensic Investigation Industry in South Africa, believing that this approach creates an environment that encourages continuous innovation and agility in the field of commercial forensic investigations.

In September 2019 the ICFP started this journey to develop and implement standards to guide practitioners in their efforts to serve the profession and aspire to the highest norms and standards.



CONFORMANCE EVALUATION PROGRAMME

After extensive research and engagement with key stakeholders, the following sets of standards were proposed and adopted on 20 July 2022:

- Attribute Standards;
- Client and Engagement Acceptance Standards;
- Information Gathering Standards (revised May 2023); and
- Reporting Standards.

The approval of the standards was followed by extensive awareness sessions hosted by the ICFP. Members were introduced to the practical implementation considerations of adopting the standards.

The ICFP board also identified a growing need to assess practitioners' implementation and adoption of these standards. This need to perform reviews resulted in the decision to develop a methodology and practice guide on how to perform practice and/or engagement reviews. The journey to develop said methodology and practice guide started in March 2024 with a meeting of experienced practitioners that were given a mandate to map out the process and deliberate on the key principles and objectives of a review process.



CONFORMANCE EVALUATION PROGRAMME

The first meeting was focussed on the aim of a review process. It was clear that the aim of reviews would be to enhance quality rather than being a process that would result in punitive measures. Practitioners also deliberated extensively on the approach to be followed i.e. a compliance review v.s. a conformance review. Consensus was reached that adopting a conformance review approach would result in reviews focussing on principles rather than just completing a compliance checklist. The conformance review approach would also allow reviewers to apply their judgement and experience to evaluate complex and unique circumstances encountered in the practice / engagement that were being reviewed.

The Conformance Review Methodology is currently being drafted and the first draft will be shared with focus groups and members later this year. The adoption of the Conformance Review Methodology will be followed by a training and accreditation process of reviewers.

I would like to extend my sincere appreciation to everyone who shared their vast experience and donated their time to enhance the Commercial Forensic Investigation industry. Your contributions are shaping the practitioner and practice of the future.

DEVELOPMENT AND TRAINING

The Institute of Commercial Forensic Practitioners (ICFP) hosted nine training events between August 2023 and May 2024, attracting a total of 1,454 attendees. These events covered a wide range of topics related to financial crime, fraud prevention, and forensic practices.

Notable events included:
