### **Programme**

- 1. Introduction to Ethical Decision-making (45 minutes)
  - Brief overview of ethics and moral decision-making.
  - Discussion on the importance of narratives in understanding ethics, referencing Nina Rosenstadt's perspective.
  - Setting the stage for exploring AGI ethics through the film "Ex Machina."

#### 2. Introduction to Ex Machina (15 minutes)

#### 3. Viewing of Ex Machina (1 hour 50 minutes)

#### 4. Debrief and Group Discussion (50 minutes)

- Facilitated discussion on the moral dilemmas presented in "Ex Machina."
